

In 2024, the Vermont Network's member organizations helped **8,422** people.




The total number of people served has increased by **13.4%** since 2021.

Statewide Projects Supported by the

Vermont Network

The Vermont Network's **Justice for Victims Legal Clinic** assisted or represented **541** clients, including cases involving domestic violence, sexual harm and/or stalking.

DIVAS, an advocacy program for incarcerated survivors, served **252** people.

116 credentialed **Sexual Assault Nurse Examiners** (SANEs) provided care for **406** survivors impact by sexual harm and other violence/abuse — **117** children and youth and **289** adults.

Deaf Vermonters Advocacy Services (DVAS) helped **65** Deaf and hard-of-hearing Vermonters.

485 Vermonters participated in a **Domestic**Violence Accountability program.⁴

The CDC estimates that over their lifetimes, **251,000** Vermonters have experienced intimate partner violence and **259,000** have experienced sexual harm⁵ – more than **40,000** each year.

We estimate this violence costs the state well over **\$111** million per year in public funding alone.⁶

Footnotes:

- 1. Non-Binary or Unknown includes individuals whose gender was not specified or who identify outside the binary; limitations in Vermont Network's 2024 data aggregation currently prevents further distinction.
- 2. Sexual harm includes victims of sexual harassment, sex trafficking, child sexual abuse, and sexual violence.
- 3. Domestic violence includes people abused by an intimate partner as well as children impacted by domestic violence.
- 4. The Vermont Network coordinates Vermont's Council on Domestic Violence which certifies these programs.
